RULES/RATES & REGULATIONS AGREEMENT 206-938-DOGS

The following are requirements that must be met before your dog attends WS Dog House Daycare, LLC facility:

1. All dogs must be at least 15 weeks of age.

2. All dogs must have a complete & up-to-date application on file.

3. All dogs over 8 months of age must be spayed/neutered.

- All dogs must provide proof of up-to-date on the following vaccinations: Rabies if over 6 months
 Bordatella (kennel cough)
- 5. All dogs must be in good health and free of any communicable diseases.

All dogs should be on a flea control program.

All dogs must be non-aggressive & not food or toy protective.

Daycare

- All dogs should be fed prior to drop-off. Upon request, dogs will be fed during visit food to be provided by owner.
- Each dog needs both leash and collar (breakaway preferred) with current name tag.

Reservations/cancellations are required 24 hours (one day) prior to visit.

Hours for drop-off & pick-up are Monday through Thursday - 7AM-6:00PM. (closed Friday, holidays & weekends). An additional fee of \$1 per minute may be applied for extended times.

HOURS

WS Dog House is open for daycare services from 7-am to 6:00P Monday-Thursday. Closed to humans Fridays (also closed weekends & holidays). Morning drop-off time is 7 -8:45A / Evening pick-up us 4 - close. Outside those times please call to arrange pick-up or drop-off.

RATES

All services are to be paid on the day of service or in advance for any package deals. Any packages must be used within 60 days of purchase. Reservations/cancellations must be made 24 hours in advance.
